INVITATION TO APPLY FOR ELIGIBILITY AND TO BID

1. The **Technology Application and Promotion Institute (TAPI)**, of the Department of Science and Technology through the CY 2017 General Appropriations Act intends to apply the sum of **One Million Six Hundred Thousand Pesos (PhP1,600,000.00)** being the Approved Budget for the Contract (ABC) to payments of the "**Supply and Delivery of Tarpaulin Printer**". Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Technology Application and Promotion Institute (TAPI)** now invites bid for the "**Supply and Delivery of Tarpaulin Printer**". Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the project. The description of the eligible bidder is contained in the Bidding Documents, particularly, in Section II – Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of the Republic Act (RA) 9184, otherwise known as "Government Procurement Reform Act".
4. Interested bidder may obtain further information from TAPI Bids and Awards Committee (BAC) and inspect the Bidding Documents at the address given below from 9:00 AM to 5:00 PM, Monday-Friday.
5. A complete set of **Bidding Documents** may be purchased by interested Bidders on **November 09, 2017** from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of Five Thousand Pesos (PhP 5,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) (www.philgeps.gov.ph) and the website of TAPI (www.tapi.dost.gov.ph) provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

TAPI will hold a **Pre-Bid Conference** on **November 06, 2017, 10:00 AM** at the **TAPI Audio Visual Room, DOST Compound, Gen. Santos Avenue, Bicutan,**

Taguig City, which shall be open to all interested parties who have purchased the Bidding Documents.

6. Bids must be **delivered/submitted** to the address below on or before **November 20, 2017, 11:00 AM** (refer to TAPI Digital System clock). **Submitted Bids must be deposited/dropped** at the **Bid Box** located beside TAPI Guard Post. All bids must be accompanied by a **letter of intent** and a **bid security** in any of the acceptable forms and in the amount stated in ITB Clause 18.

The **Bid Opening** shall be on **November 20, 2017** at the time stated above at the Audio Visual Room of TAPI, DOST Compound, Gen. Santos Avenue, Bicutan, Taguig City.

7. Bids will be opened in the presence of the bidders or bidders' representative who choose to attend. Bidder's representative must be duly authorized by the management of the company represented through a Special Power of Attorney. Late bids shall not be accepted. TAPI reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to affected bidder or bidders.
