The bidder shall enclose in a sealed envelope his bid together with his minimum bid bond equivalent to ten percent (10%) of his bid in the form of cash or cashier's or manager's check. The envelope should also include documents applicable as stated above. Bid shall be offered personally by the company owner or in his absence, his duly authorized representative, provided said person/entity possesses a duly notarized Special Power of Attorney (SPA), otherwise,

said bid shall be declared void. Prior to the issuance of the Notice of Award, the winning bidder should present the original copy of the foregoing documents for validation.

Sealed Bids received shall be opened on <u>09:35 A.M. of June 20, 2023 - Tuesday</u> at the Audio-Visual Room (AVR), 1st Floor of TAPI Building, DOST Compound, Bicutan, Taguig City. The biometrics clock located at the lobby 1st Floor of TAPI Building, DOST Compound, Bicutan, Taguig City, will be the basis for the time.

The bidder's bond will be returned to the non-winning bidder right after the bidding. On the other hand, the bid bond of the winning bidder shall form part of the purchase price. However, the ten percent (10%) bid bond shall be **forfeited if the full price is not paid by the winning bidder within the prescribed period stated in the Notice of Award**. The bid bond shall be considered as partial payment and the difference between such payment and the offer shall be paid in the form of cash, cashier's or manager's check of a reputable bank within the area where the bidding was held. Full payment shall be made within **five (5) working days from the date of the Notice of Award**.

TERMS OF REFERENCE

A. BACKGROUND

The Department of Science and Technology – Technology Application and Promotion Institute, Finance and Administrative Division-Property Section is conducting disposal through public auction of unserviceable properties, wherein obsolete items (equipment, supplies and other scrap materials) are no longer usable, worn-out and destroyed/damaged.

B. OBJECTIVE

There is a need for the disposal of the unserviceable properties listed below to avoid further deterioration as well as to generate greater benefits to the government in terms of higher appraisal value, lesser storage cost and better management of limited office space for unserviceable property/assets.

C. SCOPE OF PUBLIC AUCTION

D. TERMS AND CONDITIONS

- 1. The sale is on "AS IS WHERE IS" basis.
- 2. A bidder shall bid on 1 lot of all the unserviceable items as listed.
- It is understood that participating bidders have seen and inspected the subject unserviceable properties located in the DOST-TAPI Basement and outside of Storage Room inside the DOST Compound Bicutan, Taguig City.
- To clarify and/or explain any of the requirements, terms and conditions stipulated in the bid documents, a Pre-Auction Conference shall be held on <u>June 15, 2023</u> <u>- Thursday - 02:00 P.M.</u> at the Front Lobby, 1st Floor of TAPI Building, DOST Compound, Bicutan, Taguig City.
- Sealed bids addressed to MR. JOYCEL N. AGUILAR, Chairperson, DOST-TAPI Appraisal and Disposal Committee, shall be submitted not later than <u>09:30 A.M. of June 20, 2023 Tuesday</u> at the Front Lobby, 1st Floor of TAPI Building, DOST Compound, Bicutan, Taguig City. The sealed envelope must contain the Bid Tender and Bid Bond.
 - Sealed Bids received shall be opened on 09:35 A.M. of June 20, 2023 Tuesday at the Audio-Visual Room (AVR), 1st Floor of TAPI Building, DOST Compound, Bicutan, Taguig City. The biometrics clock located at the lobby 1st Floor of TAPI Building, DOST Compound, Bicutan, Taguig City, will be the basis for the time.
- Bids shall be submitted using the prescribed Bidding Form (ANNEX A) and in strict compliance with the requirements of these Instructions.
- 7. The modification/erasure, if any, should bear the initial of the bidder.
- 8. The bid shall be accompanied by a bidder's bond in the form of Cash or manager's check equivalent to 10% of the total amount of bid, as guarantee that the successful bidder shall, within five (5) working days from the date of the Job/Release Order, withdraw the items from its present location.

- A bidder may be allowed to withdraw his tender before the time of the opening of bids and shall be returned unopened. After the opening of bids, no bidder shall be allowed to withdraw his offer.
- No bids shall be accepted after the deadline set at <u>09:30 A.M. of June 20, 2023</u>
 <u>Tuesday</u>.
- 11. Bids that are not in the prescribed form or unsigned shall be considered defective and shall be automatically disqualified.
- 12. Bid bond of non-winning bidders shall be returned upon written request after the winning bidder has been determined.
- 13. Award shall be given to the highest complying bidder and whose bid price is not lower than the total floor price for the unserviceable items.
- 14. Should there be two or more bidders who submit the same bid price for the items shall be resorted to determine the winning bidder. (Through Draw lots)
- 15. Should the bid offer received is lower than the floor price or should there be no bidder for the unserviceable properties, re-bidding shall be resorted. In case of a two failed bidding, negotiation still be resorted to, provided that the price shall not be lower than the minimum floor price as determined by the Disposal Committee.
- 16. Upon determination of the awardee, the bid bond shall be considered as partial payment and the difference between such payment and the offer bid price shall be paid in the form of cash, cashier's or manager's check of a reputable bank within the area where the bidding was held. Full payment shall be made within five (5) working days from the date of the Notice of Award.
- 17. A storage fee in the amount equivalent to 1% of the total unwithdrawn items or Five Hundred Pesos (P500.00) whichever is higher shall be charged against him per day of delay. Items not withdrawn five (5) working days from the date of Job/Release Order may be re-bid and all money received in connection with the said sale shall be forfeited in favor of DOST-TAPI;
- 18. Should the winning bidder failed to pay the full amount of the bid price within five (5) working days from the date of the Notice of Award, the same shall be deemed canceled and rendered ineffective and the 10% bond deposit forfeited in favor of the DOST-TAPI;
- 19. No transfer or Deed of Assignment of the Award shall be honored by the items. Awardee or his representative is required to personally pay, withdraw and/or request extension of withdrawal, if warranted, for the awarded items;
- Withdrawal and loading of unserviceable items/scrap of the items shall be made only during official working hours from 08:00 AM to 05:00 PM, Monday to Friday.

- 21. For hauling of unserviceable items from DOST Compound, the winning bidder may be allowed to extend stay in the DOST Compound until the lifting of truck ban. Said arrangement shall be with prior coordination with the Head Security Guard.
- 22. The buyer of disposable property shall pay, in addition to the purchase price, any taxes, customs duties, cost or charges of any kind or nature whatsoever levied in connection with the sale of the property. All expenses incidental to the withdrawal of the property shall be borne by the awardee.
- 23. The Head of the Agency reserves the right to reject any and all Bids, declare a failure of bidding, or not award the contract for the following conditions:
 - (a) If there is evidence of collusion: 1) among bidders or 2) between the bidders and the DOST-TAPI Personnel, which restrict, suppress, nullify competition.
 - (b) When the award of the contract will not redound to the benefit of the government.
